Wildfire updates and resources www.GNB.ca/FireWatch

"The provincial fire ban will remain in place until we get steady, soaking rain across affected areas. Please respect the restrictions, stay informed and help prevent wildfires." - DNRED

The wildfires currently burning in the province are a concern to all of us. The province is bone-dry and no significant rainfall is expected within the fore-seeable future.

Yes, there has been some rain in the past week, but not enough to reduce the risk of starting new fires by being in the woods without the proper precautions in place.



Since August 10th, "Crown land closed due to an extreme wildfire hazard - As per Section 71.5 of the Crown Lands and Forests Act, all recreational activities are prohibited on Crown Land until further notice."

The restrictions provided by the Department of Natural Resources & Energy Development (DNR), and "Private property owners are also strongly encouraged to follow the same approach", include;

- hiking, camping, fishing and the use of vehicles in the woods are not permitted
- trail systems through woods are off limits
- camping is allowed only in campgrounds

On Tuesday, August 19, DNR announced that "Some businesses are allowed to resume operations on Crown lands under strict conditions."

On Wednesday, DNR held a meeting with the Federation and other stakeholders to clarify what is and what is not permitted in the woods at this time - for both Crown and Private land. We have updated our <u>website</u> with that information, and will continue to update it as new details are received, but for the latest updates, check <u>www.GNB.ca/</u>FireWatch.

Clarification on restrictions and permitted activities on Crown and Private land from DNR (Aug 20):

Many forestry operations, including the following, are currently prohibited on both Crown and Private land

- harvesting / forwarding / skidding
- site preparation, such as scarification
- chipping
- all pre-commercial thinning and cleaning
- vegetation management, including spraying herbicides

To ensure ongoing operations of the forestry sector, specific activities with appropriate conditions to mitigate fire and safety risks will be permitted. All work in the forest requires a permit (on both Crown and Private land) and must adhere to rules regarding work location, operating conditions, hours of operation, fire equipment and fire-watch activity.

No activity will be allowed in an active fire zone.

Some examples;

- using a chainsaw on a private woodlot would currently require a permit
- tree planting could be allowed, and still require a permit
- some nighttime harvesting and trucking could be allowed, and require a permit

All permits will indicate what conditions must be met (e.g. specific location, required fire fighting equipment to have, if someone if required to monitor the work area for 3 hours afterwards, etc.)

Contact the Department of Natural Resources (1-833-301-0334) should you have questions, or want to apply for a permit. (Note - they have a backlog of people to contact already, so please be patient.)

Be smart. Be responsible. Be safe.

This time of restrictions for being in the woods WILL end once the risk of starting new fires is significantly reduced. It may still be a few weeks, but please be patient. Rain will happen.

Stay out of the woods if you can. If you have to work, you MUST contact DNR and get a permit!

From the Desk of the Executive Director

This year continues to be eventful! With tariffs and wildfires raging, 2025 is challenging to say the least.

To date (August 21), there has been no loss of life or infrastructure due to the fires, and for that we can be thankful. We hope you remain safe from the fires and that rain happens soon.

The Federation continues to move forward with the **carbon** file. A committee has been struck, and we are moving toward determining what the agreements might look like. The committee will also work toward determining a timeline for the establishment of such a project, the costs involved, and try to forecast what returns could be for the parties involved. There are a great number of decisions to be made.

The establishment of a <u>Private Protected Areas</u> program received a boost from the **Department of Natural Resources**. The department may have some Environment and Climate Change Canada (ECCC) money that could be used by the Federation and the Nature Trust to work out the details of such a program and work with the department to determine the requirements for such properties to meet the Other Effective area-based Conservation Measures (OECM) criteria. Essentially, OECMs are areas where conservation is happening as a positive side effect of other activities, even though the primary purpose is not conservation. An example would be a park. We will also work with the department to examine the potential for incentives for woodlot owners to participate in such a program.

There were meetings with Service New Brunswick, Department of Environment and Local Government and others from the government as part of the government promise to **review the property tax system** as part of their election platform. We raised the fact that forests provide many ecological goods and services and as such deserve to have a low tax rate, that takes these social benefits into account. We are relatively happy with the assessment of woodlots and hope to see them remain as they are.

The Federation is looking to **hire an administrative assistant/bookkeeper** to increase our human resources and better allow us to free up time to work on the new initiatives, such as Private Protected Areas and carbon.

The **AGM will be on October 8th** at the Ramada Fredericton, and Minister John Herron and David Coon, leader of the Green Party of NB, have both indicated that they will be in attendance. We continue to work on the speakers for the meeting. Should anyone have any topics that you would like us to explore, please let me know.

As part of the annual meeting, we will have elections for 3 board positions as well as the position of Federation president. These are three-year terms. Any member of the Federation is eligible to sit on the board of directors, and the nominating committee will search for members respecting geographic, linguistic and woodlot size diversity. They are also looking for diversity in gender and age. Should you be interested in sitting on the Federation board or know of someone whom you think would be a good board member, please let us know.

<u>Registration</u> for the annual meeting is open. Please go to our website to register. We look forward to seeing you there.

Federally, we continue to work toward group insurance rates in a number of areas. We hope to have this program up and running by 2026.





We look forward to seeing you there!


Carbon Committee

Towards Resilient Woodlots: Risk Assessment and Mitigation A project to understand the challenges of the Wabanaki-Acadian forest

Take a moment and look at the first tree that catches your eye. What do you see? Most likely a peaceful silhouette, a source of tranquility that passes through the seasons with serenity...

Yet, behind this calmness lies a complex forest dynamic. Countless interactions between species and their environment take place to maintain the natural balance of the ecosystem, whether they are beneficial, neutral, or even stressful!

Environmental stresses thus play a role in this dynamic. However, with current climate change, they are becoming more frequent and intense, disrupting the balance of forest ecosystems.

The Wabanaki-Acadian forest is no exception! It is facing increasingly difficult challenges that are significantly weakening it. Recent events in New Brunswick are a striking illustration of these climatic conditions: an unprecedented drought, marked by large-scale wildfires! Strengthening the resilience of this forest ecosystem is therefore essential to mitigate risks and help it adapt to future changes.

The project "Towards Resilient Woodlots: Risk Assessment and Mitigation" will help you better understand the risks threatening the Wabanaki-Acadian forest in a changing climate. You will learn how to assess these risks and discover strategies to mitigate their impact on your woodlot.

- Tree species at risk
- Drought
- Wind
- Pests and diseases
- Wildfires

TREES AROUND THE WORLD Monkey Puzzle Tree (Araucaria araucana)

Yes, you read that right: it's really called "Monkey Puzzle Tree"!

This nickname is said to come from an amusing remark made around 1850 by a man named Charles Austin: "it would puzzle a monkey to climb that".

It is even more amusing given that no monkeys live in the natural habitat of this tree, a region of the Andes between Chile and Argentina.

That said, this conifer lives up to its name with its unique silhouette and thick, sharp, scale-like leaves that densely overlap along the branches, giving them a reptilian appearance. No wonder it is Chile's national tree!
